Over the next five years, AIHW will:

Our stakeholders are diverse and include Australian Government, state and territory governments, research communities, non-government organisations and the Australian public. We will innovate, and produce targeted data sets and analysis that is useful to our stakeholders, and which enables them to improve their advice and decision making.

2.2 Identify and fill priority data gaps

We will determine and close priority data gaps through data collection, collation, and analysis of nationally consistent data. We will also seek out opportunities created by data linkage (while protecting privacy), explore new data sets that bring greater insights to health and welfare issues. We will explore options for digitalisation and integration of existing data sources and investment in new systems and collections.

Facilitate sustainable and secure access to timely, relevant and fit-for-purpose data and analysis

We will enhance and streamline our data governance arrangements to improve availability of data to researchers, decision makers and the broader community. We will ensure strong privacy protections and transparent and ethical decision making.
